

## LETTER FROM THE PRESIDENT

With great enthusiasm, I present the 2024 Roane Alliance Annual Report, reflecting a landmark year defined by groundbreaking achievements, robust community engagement, and our team's dedication to launching transformative events that benefit Roane County.

The Roane Chamber of Commerce has had another stellar year, supporting our business community with more than 30 ribbon cuttings, showcasing significant growth. Our Ambassadors have been instrumental in these efforts, devoting their energies to enhancing the Chamber's reach and impact across the community.

This year, our 38 volunteer Ambassadors and leaders within our community have gone above and beyond in supporting the Chamber's initiatives. They've participated in numerous events, including the ROAM'R Jeep Festival and Kid's Cafe, fostering connections and community spirit. The Ambassadors have reinforced their team dynamics with regular monthly meetings and strategic planning sessions, maintaining excellent attendance and making six impactful contributions to the community in 2024. Noteworthy initiatives include their bi-yearly involvement in the Adopt-a-Highway program and regular support for local law enforcement through the Adopt-a-Cop program.

Our inaugural Industry/Education Collaboration Summit, Connect Roane, was a resounding success. Nearly 60 industry and education leaders met on October 30th to discuss workforce challenges and successes at the Oak Ridge Emergency Response Training Facility, exemplifying our commitment to fostering collaborative growth.

Roane County shined brightly with several signature events. The Tennessee Bass Nation & Youth State Open at Rockwood's Tom Fuller Park attracted over 250 boats, highlighting our county as a premier destination for fishing tournaments. The ROAM'R Jeep Festival at the Swan Pond Sports Complex in Harriman debuted with over 200 Jeeps and 800 attendees, complementing the continued success of the Tennessee Medieval Faire, which once again recorded high attendance across its three weekends in October.

The October Sky Festival in Oliver Springs continues to grow. Now in its 16th year, it draws over 5,000 attendees and over 100 vendors, cementing its place as a key event in our community calendar. The City of Kingston's 225th birthday celebration on October 23rd was a historic event attended by notable dignitaries and marked by community pride and heritage appreciation.

The Roane County Industrial Development Board has been pivotal in advancing our economic landscape. Significant developments include Protomet Corporation's expansion, which is set to create 250 new jobs and represents a \$25 million investment in Rockwood.

A historic highlight was Governor Bill Lee's announcement of the largest single investment in Tennessee's history. Orano USA's decision to build a major uranium enrichment facility in Oak Ridge represents a more than \$5 billion investment and will create over 325 high-paying jobs.

We remain optimistic about the future as we reflect on these remarkable accomplishments. Our collective achievements have been made possible by the unwavering commitment of our dedicated team, who work tirelessly each day to fulfill the Roane Alliance's mission: to create an environment and unified voice that promotes job creation, economic development, enhanced quality of life, education, and workforce development across Roane County.

Our passion and determination seek to ensure that our county is a destination and a thriving community where people are proud to live, work, and play. Together, we are shaping a brighter future, united in our efforts to make Roane County a beacon of opportunity and excellence.



# ABOUT THE ROANE ALLIANCE


The Roane Alliance is the economic development agency for Roane County. As the umbrella organization over the Industrial Development Board (IDB), Visitors Bureau, and Chamber, it oversees the management and day-to-day operations of the entire team. Established in 2001 as a catalyst for 'positive economic and community development programs,' the primary reason for the Alliance was to bring the three organizations together under one roof to share operating costs and create a central location that works together to promote and market the county. A 'one-stop-shop' under one roof provides more efficiency and productivity, allowing Roane County to be more competitive and successful in promoting our quality of life and place. The Alliance also works as a forum to unite leaders, stakeholders, and residents to discuss and share key economic development issues and build consensus across the county. This annual report provides a snapshot of the Alliance's economic and community development efforts in 2024 that helped increase economic prosperity for the county and its residents.

## ROANE COUNTY JOINT ECONOMIC AND COMMUNITY DEVELOPMENT (JECD) BOARD

Established in 2001 by an interlocal agreement between the county and its municipalities, the Alliance encourages all segments of the local community to communicate about economic development issues. The Alliance administers the JECD and other programs that affect the county's ability to qualify for state grants, like ThreeStar. Without this board, local governments can not be eligible for state grants. The JECD, along with the Alliance board, meets once a quarter.

## **ROANE ALLIANCE FUNDING**

The Alliance budget is funded through contributions, the Gala, and rent from the three partner organizations – the Industrial Development Board (IDB), the Visitors Bureau, and the Chamber. Fundraising is more than 75% of the Roane Alliance's total budget, so annual support through contributions, sponsorships, and donations is critical to Roane County's growth and economic success. The Alliance budget provides funds for the personnel and operating expenses needed to manage the team. The Roane County Tourism Committee and the Roane Alliance Board direct the Visitors Bureau's tourism program, while the IDB and Chamber both have their board of directors. The county determines funding for the IDB and Visitors Bureau, while the Chamber is funded through membership dues and non-dues revenue, such as a portion of the funds raised from the Roane Gala. Every partner's budget provides for not only the personnel and operating expenses but also the marketing and programming necessary for that partner to accomplish its mission, which in turn helps to achieve the overall mission of the Alliance. Pie charts showing the budget breakdown of each partner are provided in this report.

## **MORE GRANT FUNDING SECURED IN 2024**


The Roane Alliance applies for grants on behalf of the RCIDB, Chamber, and Visitors Bureau as they are available. Grants provide extra dollars annually for marketing, advertising, infrastructure, and more. This makes us more competitive and vital to a successful economic development program. One annual grant, the Tennessee Department of Tourist Development's (TDTD) Tourism Marketing Grant, almost doubles the Visitor's Bureau media marketing spend.

The TDTD announced in late 2020 that the Visitors Bureau would receive more than \$167,000 over the next five years for tourism marketing through the CARES Act. This grant funding attracts new, transformational events to Roane County, such as prestigious fishing tournaments, festivals, and city events. For example, on April 20th, 446 participants representing 226 boats from 8 states visited Rockwood for the 2024 Morristown Marine Team Trail on Watts Bar Lake. The total direct economic impact from this one tournament alone was \$338,252.

Additionally, in 2024, The Roane Alliance was awarded a \$25K ThreeStar grant administered by TNECD. The grant funding was utilized to create a new set of videos and photographs for Tourism marketing to spotlight some of our County's most beautiful and intriguing assets. Additionally, the grant funding will help to provide the development of new branded collateral updates, including all new rack cards, visitor guides, and pad maps showcasing our most recent marketing campaign, "When in Roane." ## 2024 ROANE GALA

The Gala is held to celebrate Roane County's successes and as a fundraiser for the Alliance, funding nearly half the operating budget annually. With these funds, the Alliance can continue to fulfill its mission—increase economic prosperity for Roane County citizens—through its partner organizations, the Chamber, the Industrial Development Board, and the Visitors Bureau. Essential programs like Education Matters and Retire Roane can continue to grow and expand their reach.

# ORANO USA, LARGEST SINGLE INVESTMENT IN TENNESSEE'S HISTORY

On September 4, Tennessee Governor Bill Lee, Department of Economic and Community Development Commissioner Stuart C. McWhorter, and Orano USA officials announced plans for a \$5+ billion state-of-the-art centrifuge uranium enrichment facility in Oak Ridge, marking the largest single investment in Tennessee's history.

The 750,000-square-foot multi-structure facility will be one of North America's largest uranium enrichment centers and is expected to create more than 300 direct jobs in Roane County. This groundbreaking project solidifies the region's potential to become the nuclear hub of the United States, further advancing its role in leading innovation and development within the nuclear energy sector. Orano's investment represents a transformative milestone for the area, positioning Roane County as a cornerstone of the nation's energy future.

# JUSTIN SNOW RECEIVES TEDC 2024 PROFESSIONAL OF THE YEAR AWARD

During its Fall Conference Awards Dinner on November 7th, The Tennessee Economic Development Council (TEDC) proudly announced Justin Snow, President and CEO of The Roane Alliance, as the recipient of the 2024 Professional of the Year Award. This award recognized a TDEC member's significant achievements and contributions within the economic development industry and their community. Justin's business recruiting efforts have helped Roane County land companies such as Orano USA, Malibu Boats, and Protomet Corporation.

## SAM RAYBURN ROAD EXPANSION PROJECT

The Sam Rayburn Road Expansion Project, completed in November at the Roane Regional Business & Technology Park, features a new 1,000-foot industrial-grade road equipped with streetlights and utility extensions. This enhancement provides direct access to additional developable land within the park, boosting its appeal to potential prospects considering Roane County for their ventures.

# PROTOMET CORPORATION ENGINEERING AND MANUFACTURING OPERATIONS IN ROCKWOOD

On April 10th, Tennessee Economic and Community
Development Commissioner Stuart C. McWhorter, and
Protomet Corporation officials announced that Protomet will
establish engineering and manufacturing operations in
Rockwood, bringing significant economic revitalization to the
community. By investing \$25 million to acquire and retrofit the
former Albahealth building on North Gateway Avenue, which a
multi-generational employer had vacated, Protomet is creating
250 new jobs and breathing new life into a facility with deep ties
to the local workforce. This development marks a pivotal step in
strengthening Rockwood's industrial base and supporting
economic growth in the region.

## KNOXVILLE LOGISTICS LLC

Knoxville Logistics LLC has officially broken ground on its Phase II speculative building in the Roane Regional Business & Technology Park. Their initial building in the park played a key role in attracting Malibu Boats in 2023. The new Phase II building will span 220,000 square feet and is scheduled for completion and delivery by Spring 2025. Over the past several months, we have actively marketed this facility to potential industrial prospects, and it has been generating significant interest.

# MALIBU LAUNCHED MANUFACTURING OPERATIONS

Malibu (Cobalt Boats) launched its manufacturing operations in Spring 2024 after acquiring the 260,000-square-foot Phase I speculative building in the Roane Regional Business & Technology Park in 2023. They have already begun expanding their workforce and are producing several boats daily. Employment and production are expected to continue growing to meet rising market demand.

## TOURIST SPENDING IN ROANE

Roane County continues to establish itself as a premier travel destination in Tennessee, with visitor spending playing a crucial role in the local economy. In 2023, direct visitor spending in the county reached an impressive \$74.56 million, marking a 5.3% increase from the previous year. This steady growth has helped Roane County rise to 29th in visitor spending among Tennessee's 95 counties. Tourism dollars directly benefit a wide range of local businesses, with the largest share of spending allocated to food and beverage (29%), lodging (27%), and retail (26%). Attractions such as Watts Bar Lake, regional festivals, outdoor recreation, and historical landmarks continue to draw visitors, ensuring that tourism remains a cornerstone of Roane County's economy. With an estimated 336,438 visitors in 2023—split between day-trippers and overnight guests—the county sees a steady influx of travelers who support local restaurants, hotels, shops, and recreational activities. These visitors collectively inject more than \$204,000 into the county's economy every day, providing direct support to small businesses and community enterprises.

Beyond its direct economic benefits, tourism significantly contributes to Roane County's financial well-being through tax revenue that helps fund essential public services. In 2023, state and local tax collections from tourism totaled \$7.68 million, with \$4.33 million benefiting state programs and \$3.36 million directly supporting local government initiatives. These funds play a vital role in maintaining and improving public infrastructure, education, health services,

and emergency response efforts. The financial impact of tourism helps reduce the tax burden on residents, saving each household approximately \$350 annually. Roane County's natural beauty, strategic location along major travel routes, and welcoming community make it an attractive destination for both leisure and business travelers. As Tennessee celebrated a record-breaking year with \$30.6 billion in tourist spending statewide, Roane County's continued investment in tourism promotion and development ensures it remains a key player in the state's thriving tourism industry.

## **EVENT HIGHLIGHTS**

Rockin' the Ramp on August 31, 2024, was a thrilling Labor Day event where the TN RiverLine fleet provided an incredible opportunity for participants of all ages to experience kayaking. Many children and even grandparents paddled for the first



time, making the event both rewarding and highly successful. On October 7, Roane County proudly hosted a State of TN FAM Tour, highlighting the city of Harriman to state employees who play a key role in promoting tourism. Attendees received goodie bags filled with local information and gift cards, encouraging return visits. Later in the month, Kingston marked its 225th birthday with an exciting lineup of events, including a Living History Reenactment at Fort Southwest Point, a Founders Day dinner, a fall street festival, and tournaments for pickleball and disc golf. The celebration drew numerous visitors and prominent officials, making it a memorable occasion for the community.

October also brought major sporting events to Roane County, including the TN Bass Nation Junior & High School State Open at Tom Fuller Park. Despite the rain, 242 boats filled with anglers competed, with local Kingston and Midway students excelling and earning scholarship awards. The tournament had a substantial positive impact on local occupancy as families traveled from across the state. Wrapping up the month, the Medieval Faire welcomed 8,500 patrons over three weekends - a 3% increase from the previous year. Visitors from at least 30 states and 56 Tennessee counties attended, enjoying the largest event yet, with 71 artisan and food vendors. 







## **CAREER DAY**

On April 2, 2024, the third annual Roane County Schools Middle and High School Career Day reached new heights of success. With the participation of 65 businesses, the event provided nearly 1,000 students with an unparalleled opportunity to explore diverse career paths. Students had the chance to participate in on-site interviews with select businesses, creating real-world connections and opening pathways to potential career opportunities.

A standout feature of this year's event was the ORNL Traveling Science Fair, further enriching the experience for attendees. Approximately 2,000 middle and high school students engaged with the interactive exhibits, workshops, and hands-on activities. The career day has solidified itself as a vital bridge between education and industry, empowering students to envision their future and build meaningful connections.

## TN SCHOLARS

In 2024, 103 seniors from Roane County graduated as TN Scholars, representing roughly 25% of the graduating class of 413. This achievement highlights the community's steadfast commitment to academic excellence. Since the program began, Roane County has proudly produced 1,918 TN Scholar graduates, demonstrating a lasting dedication to education and achievement. The increase in TN Scholars in 2024 marks a significant upward trend in educational success, reflecting the students' determination and the community's focus on fostering a culture of academic growth and continuous improvement.

## "GET YOUR SELEIF TO SCHOOL"

About 50 students from Rockwood Middle School visited industries in the Roane Regional Business and Technology Park in Lenoir City on December 18th. They were granted a field trip as an incentive through Roane County School's "Get Your Selfie to School" program. The students learned about each industry and the types of career opportunities they offer. The students visited E Jay Thermo and Dienamic Tooling Systems. As an added bonus, students made a stop at The Roane Alliance where they learned the basics of Economic drivers and participated in an activity to build their own community.











# TN PROMISE & TNACHIEVES RECRUITING

The Roane Alliance continues to lead recruitment efforts for mentors for our high school seniors on behalf of tnAchieves and the Roane County Executive. In 2024 we, again, met and exceeded our recruitment goal. We achieved 132% of our mission of 34 mentors. With each mentor recruited, fewer students are assigned to each mentor.

# EDUCATION & INDUSTRY COLLABORATION

The inaugural Connect Roane: Education & Industry Collaboration summit was a resounding success, bringing together over 55 participants from the education, business, and workforce development sectors. This event served as a platform to foster meaningful dialogue and partnerships aimed at strengthening workforce pipelines in Roane County. Attendees engaged in panel discussions, workshops, and networking opportunities, gaining valuable insights into aligning education and training programs with industry needs. The summit marked the beginning of an ongoing quarterly initiative to address workforce challenges and opportunities collaboratively. ## POLITICAL EVENTS

The Roane Chamber hosted its 2024 Legislative Breakfast on February 19th. This special event brought together elected officials and distinguished guests for insightful discussions on legislative priorities, local initiatives, and community development.
